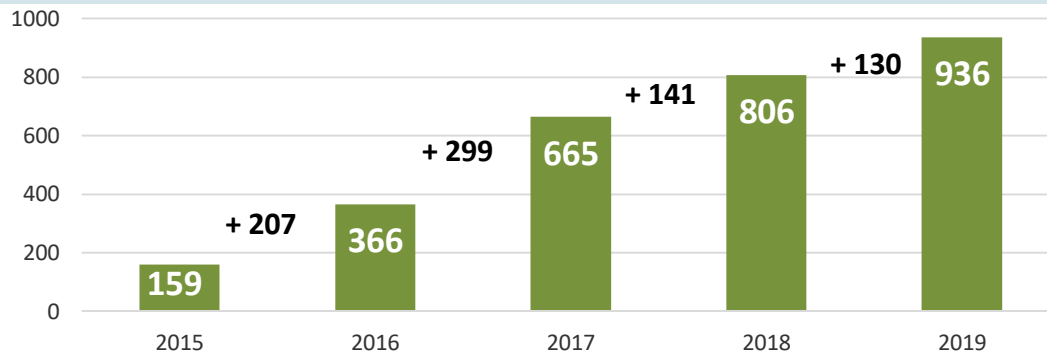

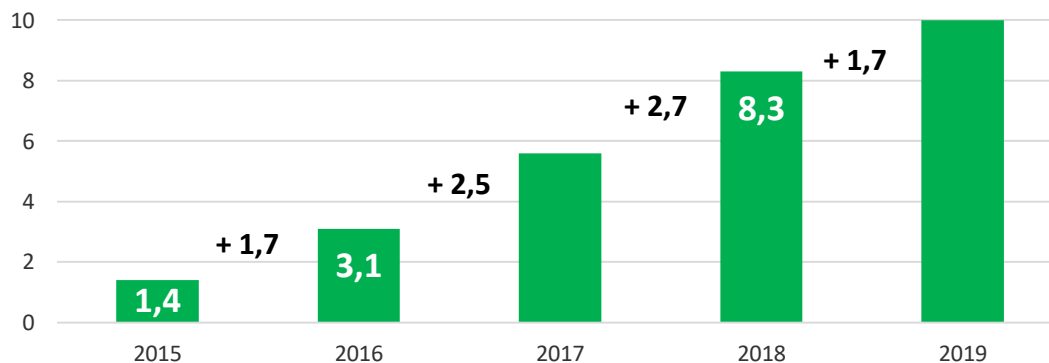

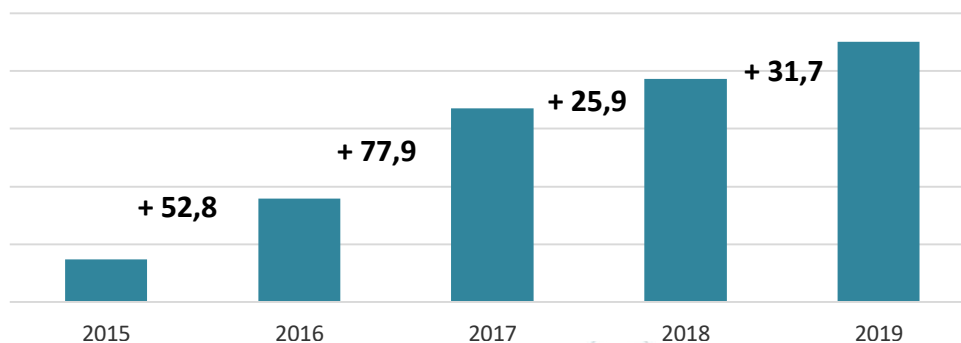

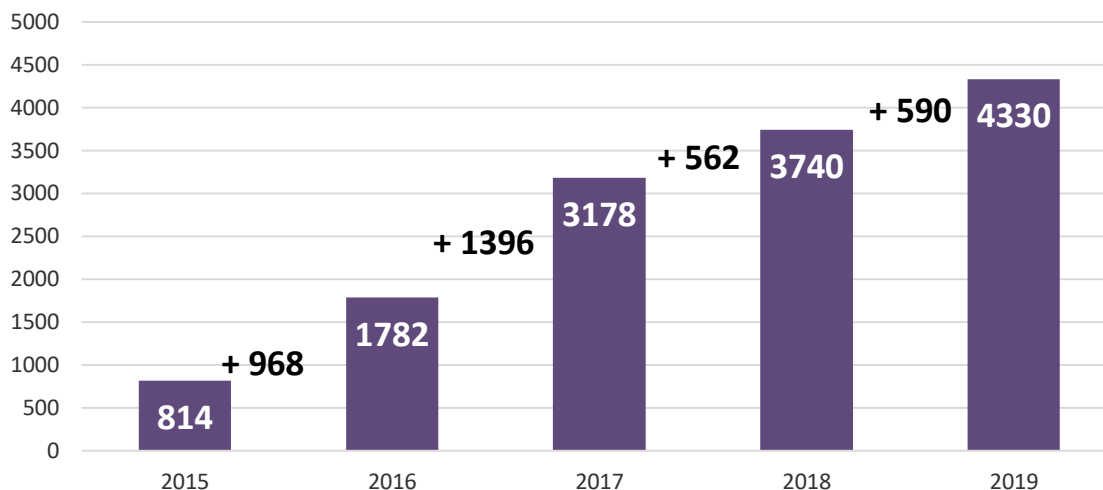

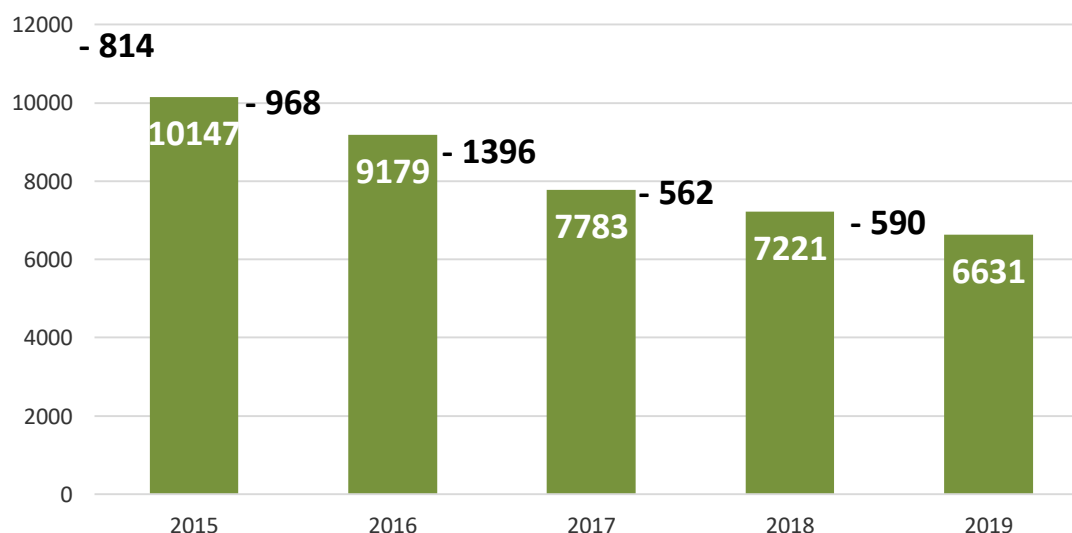

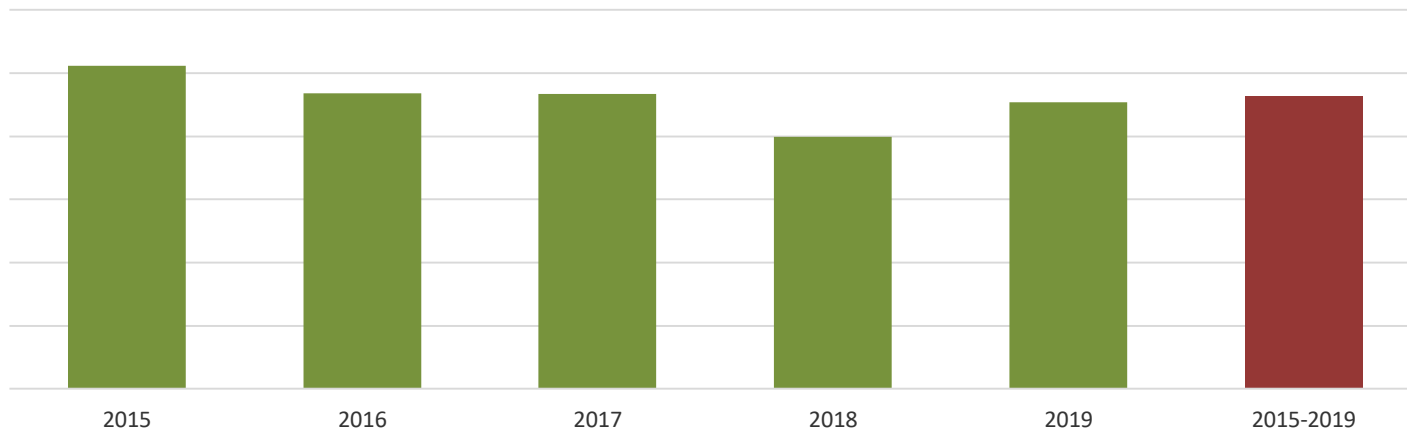

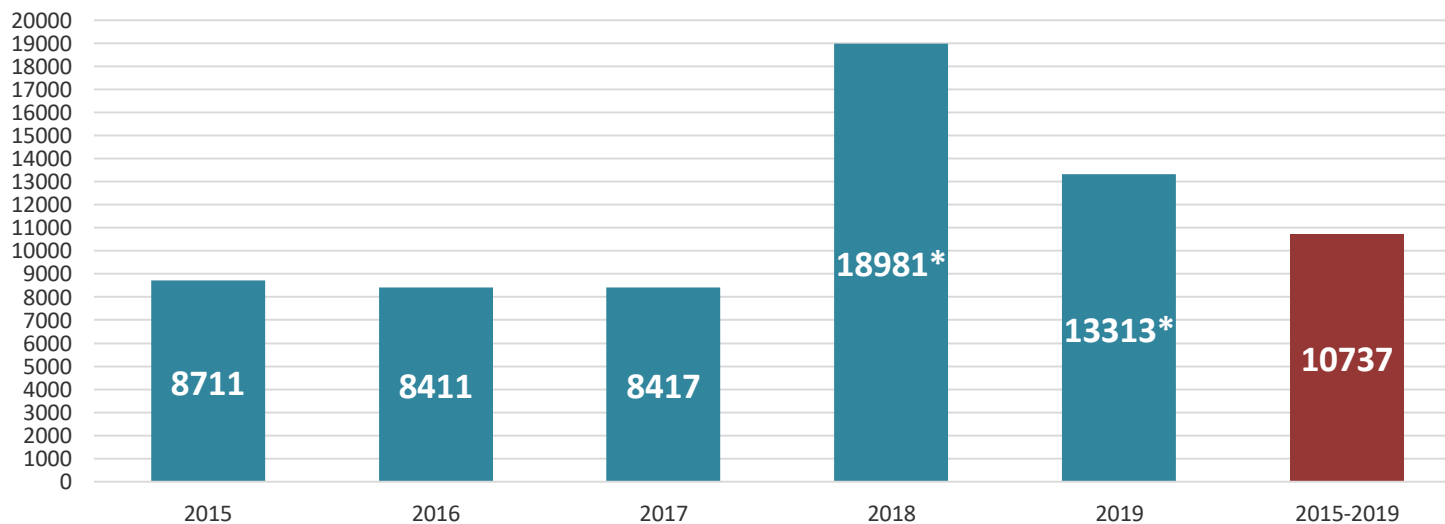

Average number of hromadas amalgamated into one AH

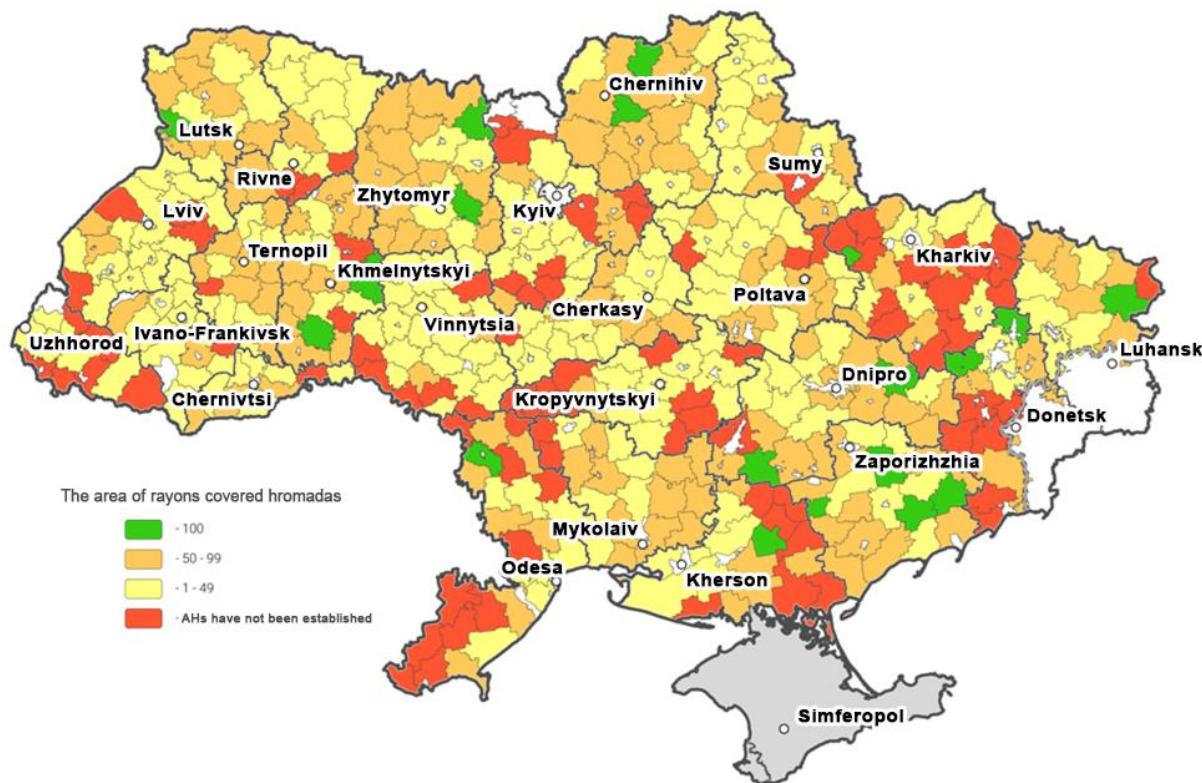


Average population of one AH (persons)

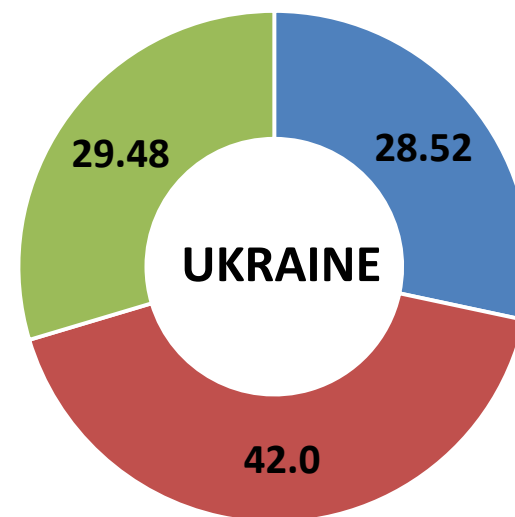

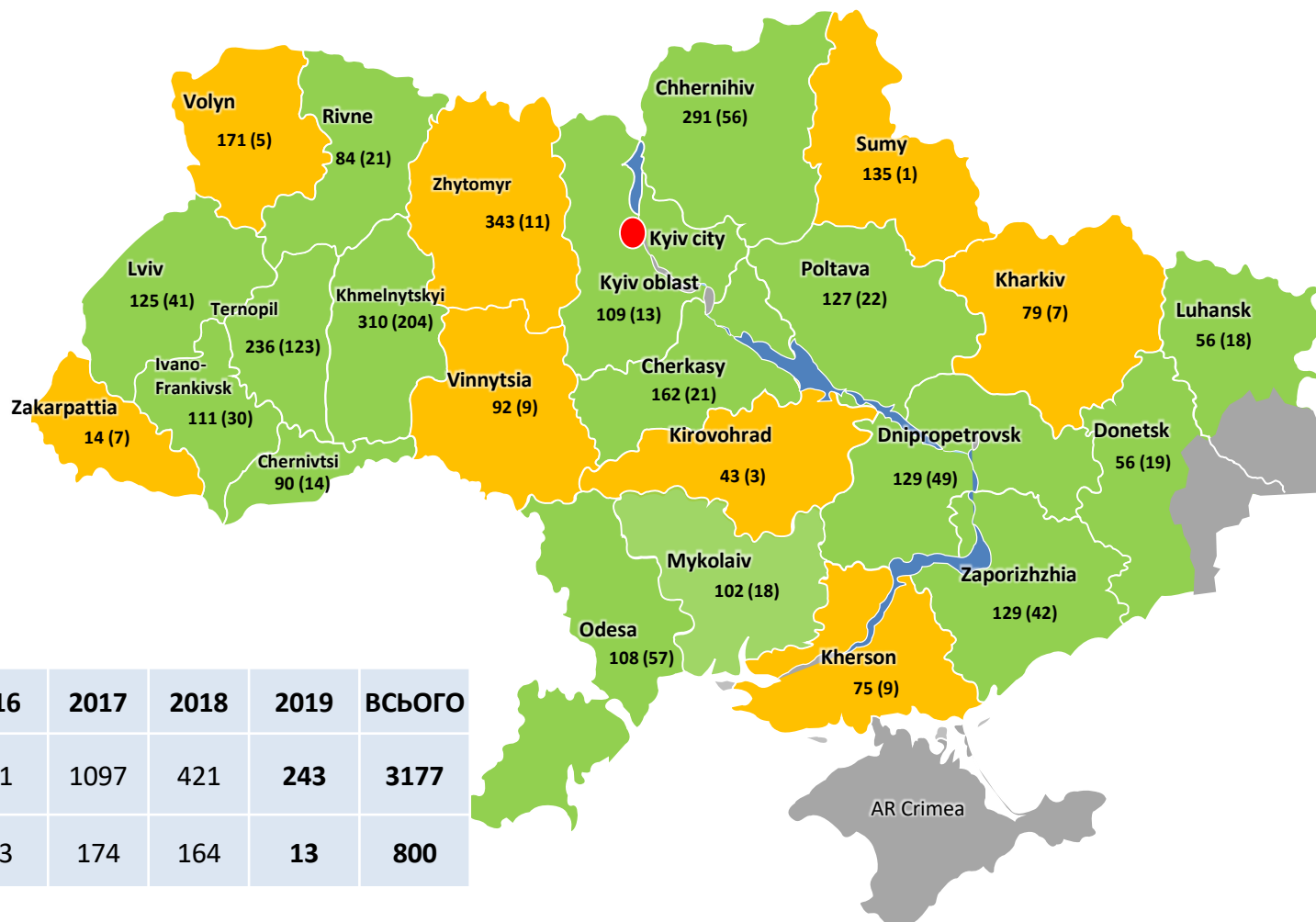

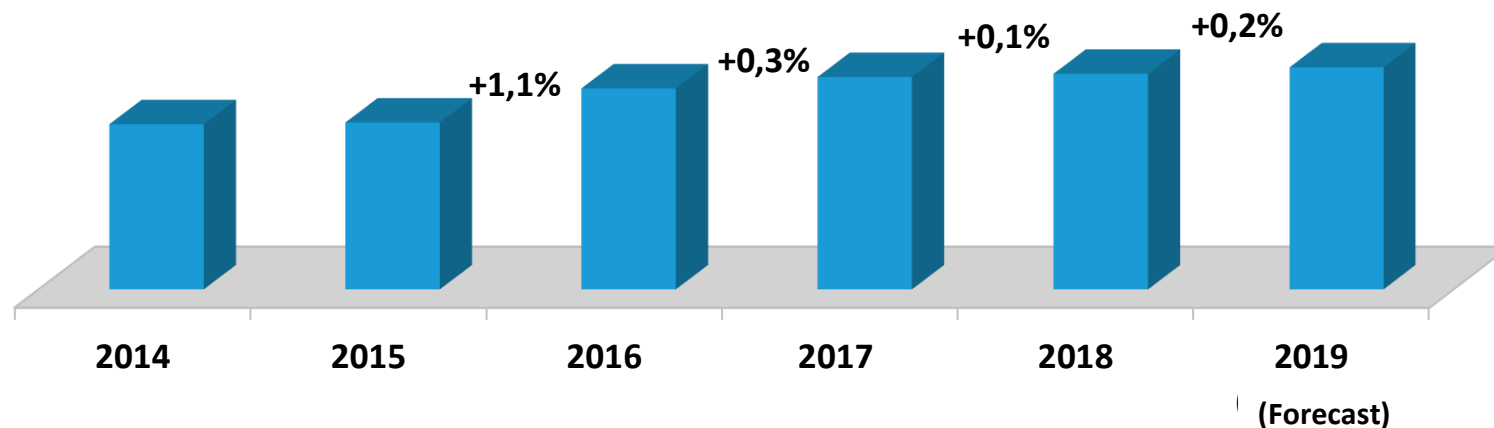

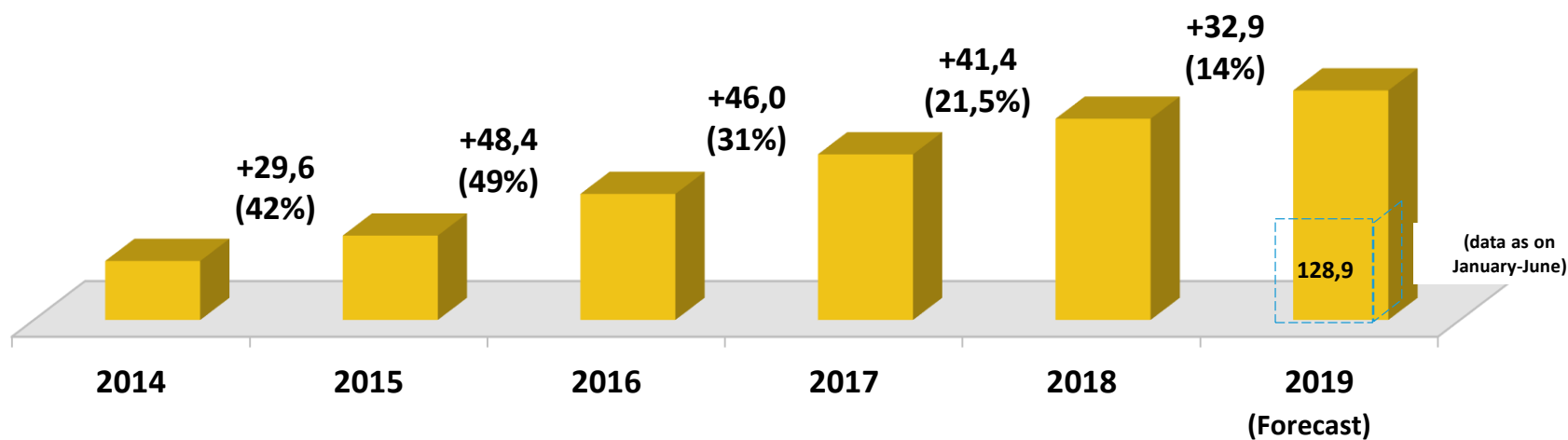

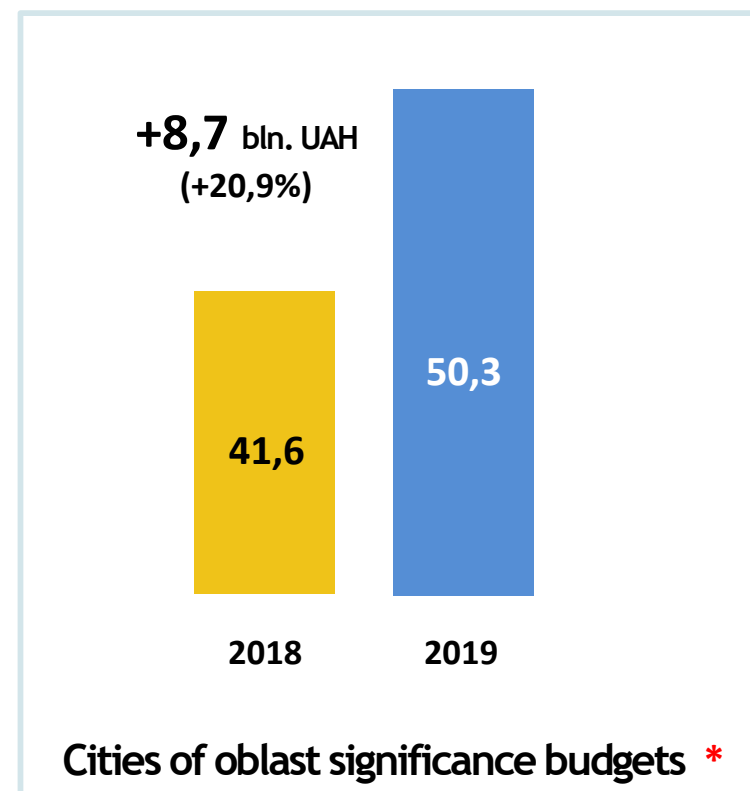
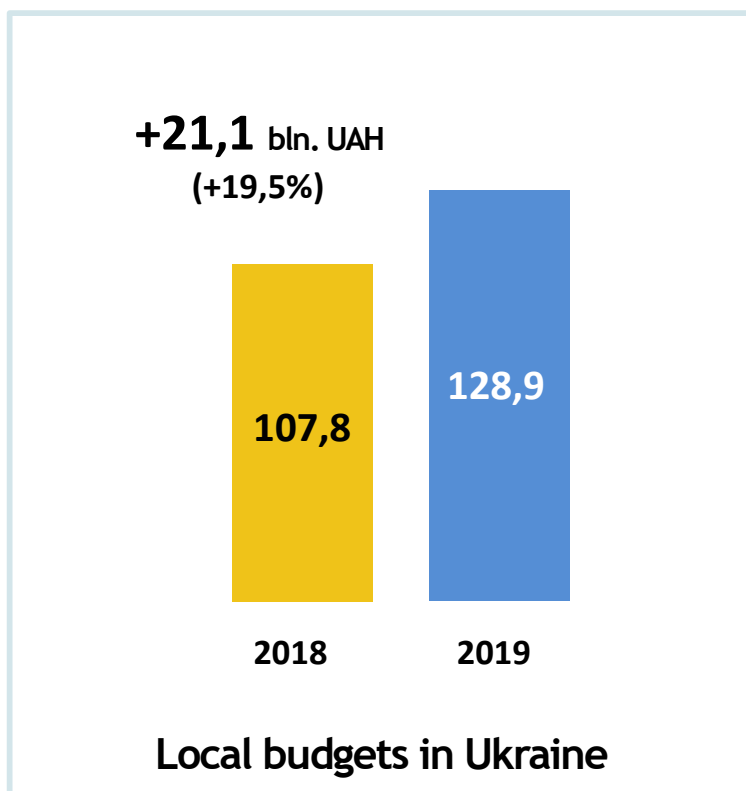
Local budget own revenue (general fund) share in GDP, %



Local budget general fund own revenue, bln. UAH

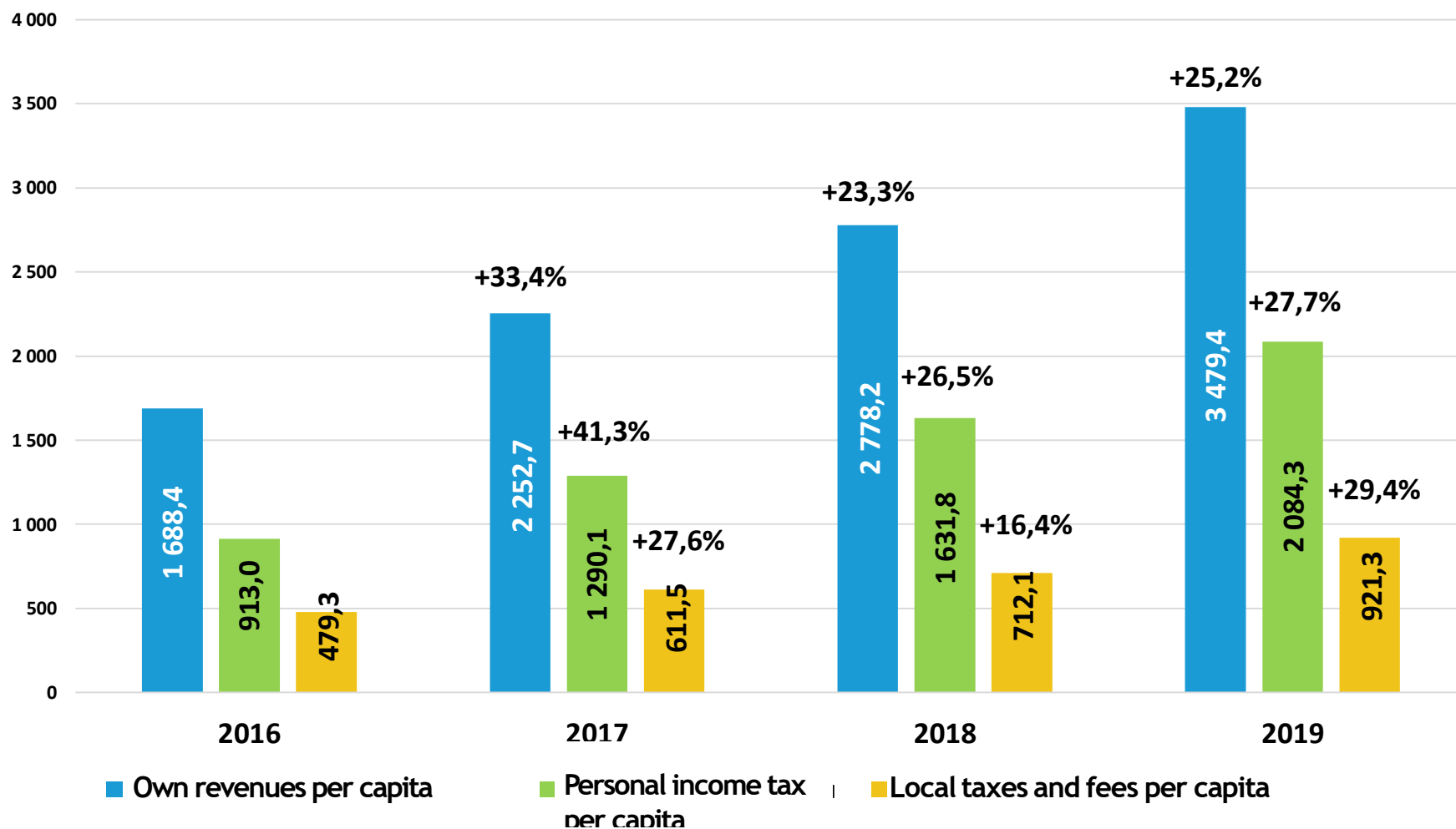


Execution of local budget revenues in January – June 2019 , compared to
January – June 2018, bln UAH (%)

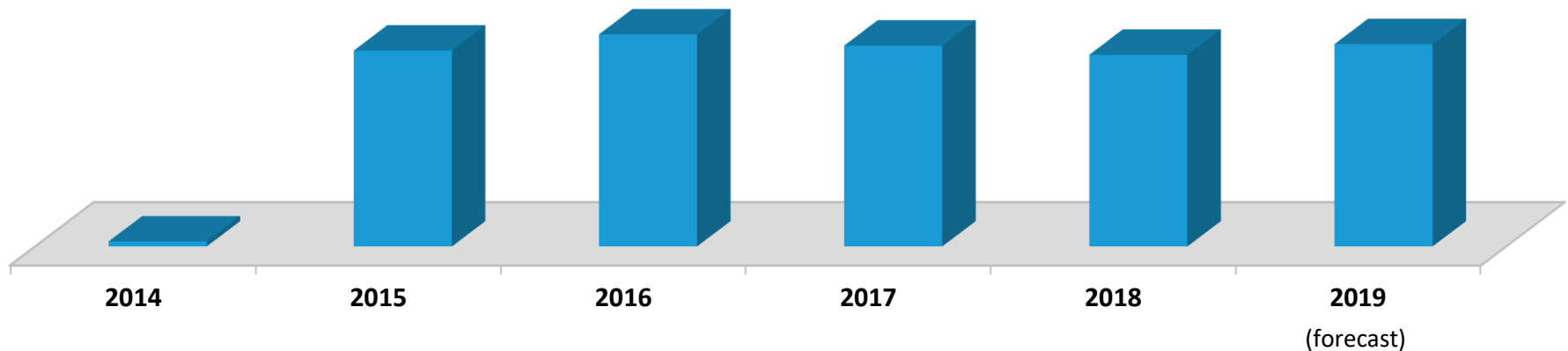

per capita for January- June 2016-2019, % and UAH

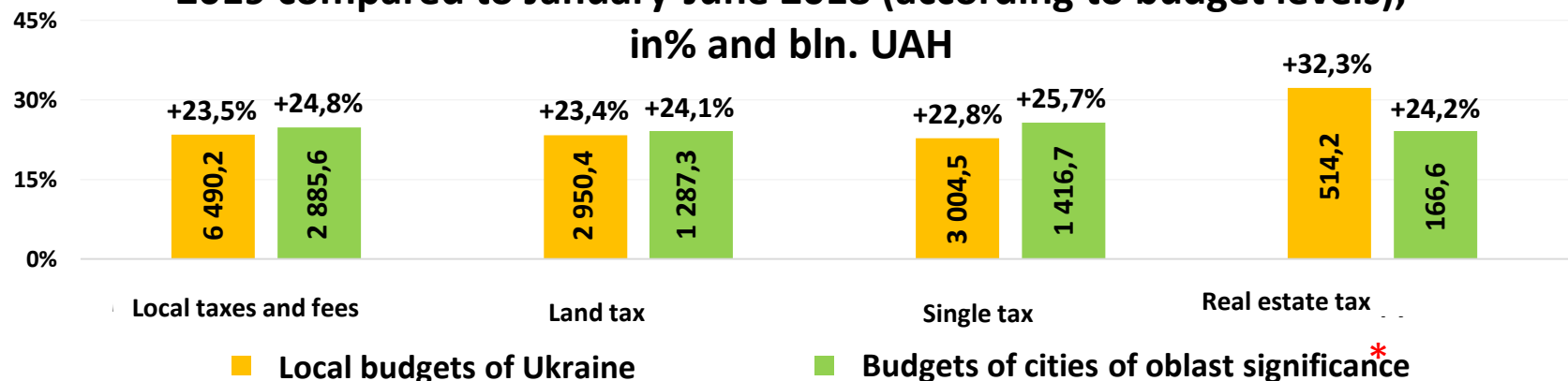


Share of local taxes and fees in the local budgets own revenues (general fund), %



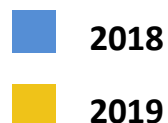
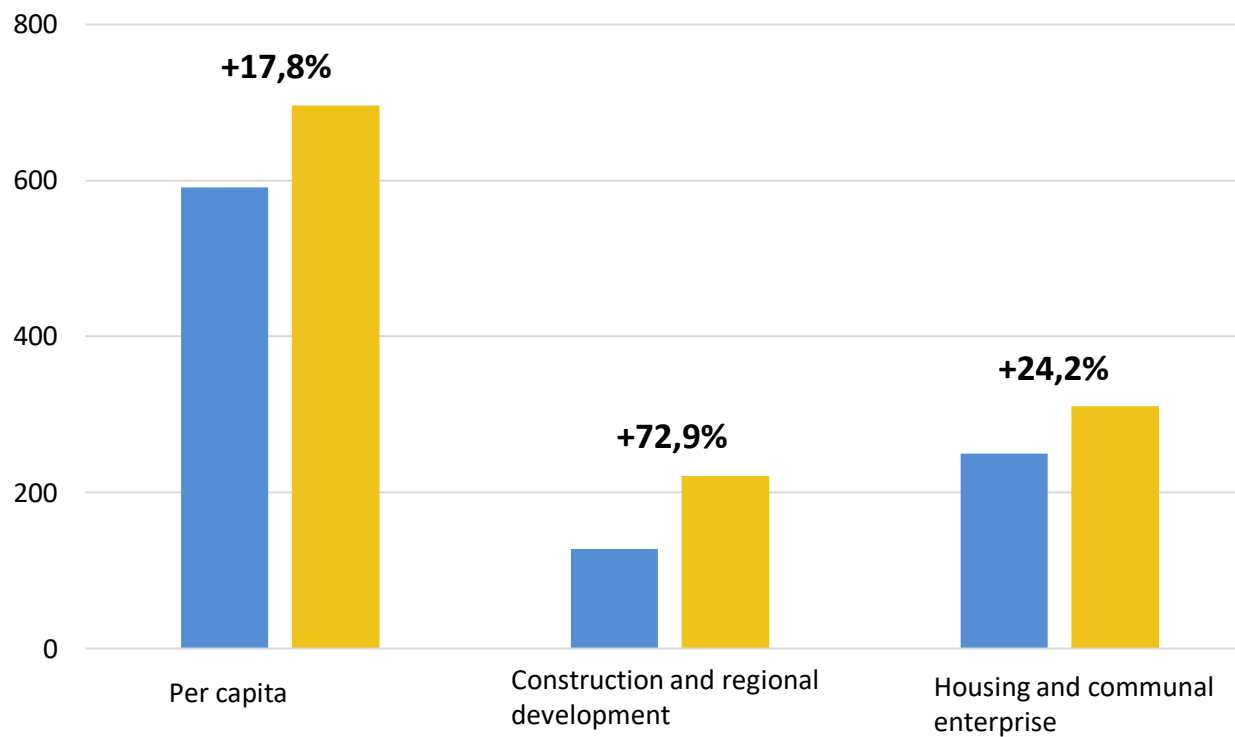
Growth rate of local taxes and fees in local budgets in January - June

2019 compared to January-June 2018 (according to budget levels), in% and bln. UAH

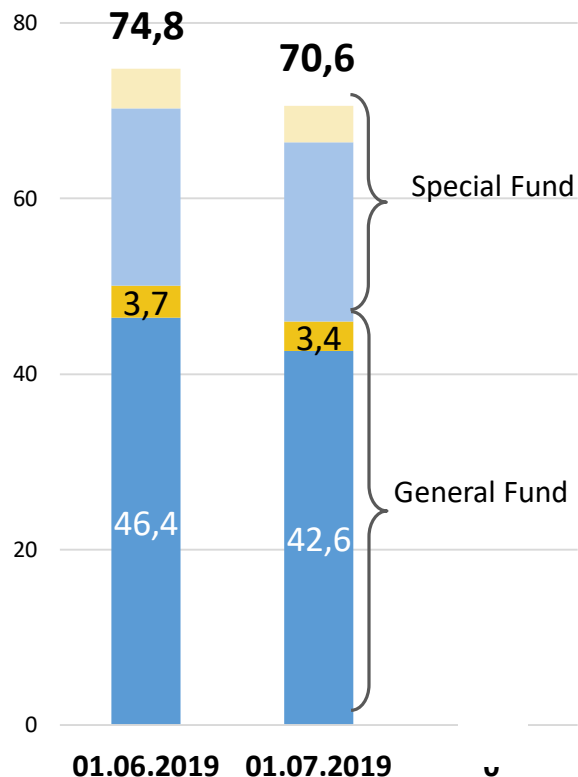

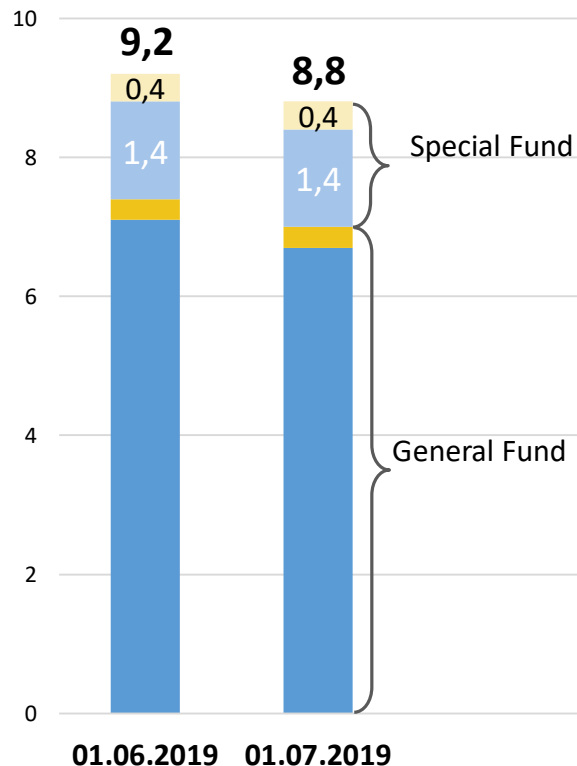
**Expenditures per capita for January-June 2018

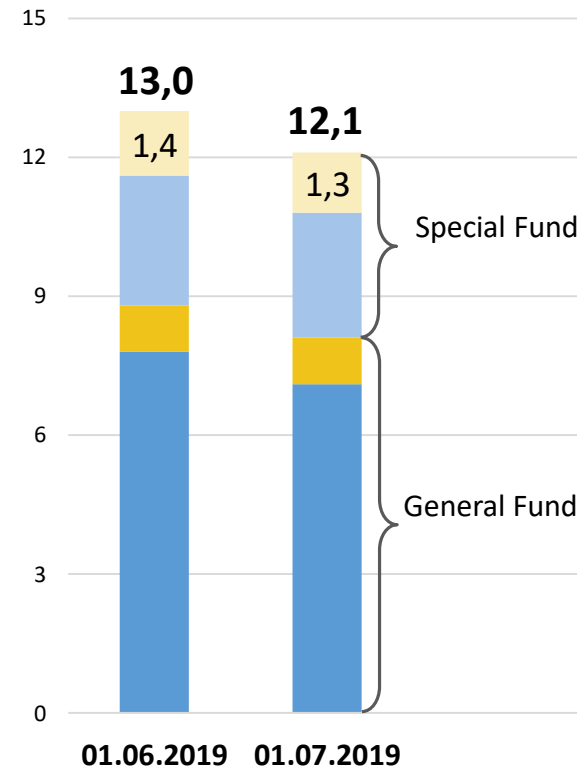
Remaining balance of local budgets, bln. UAH

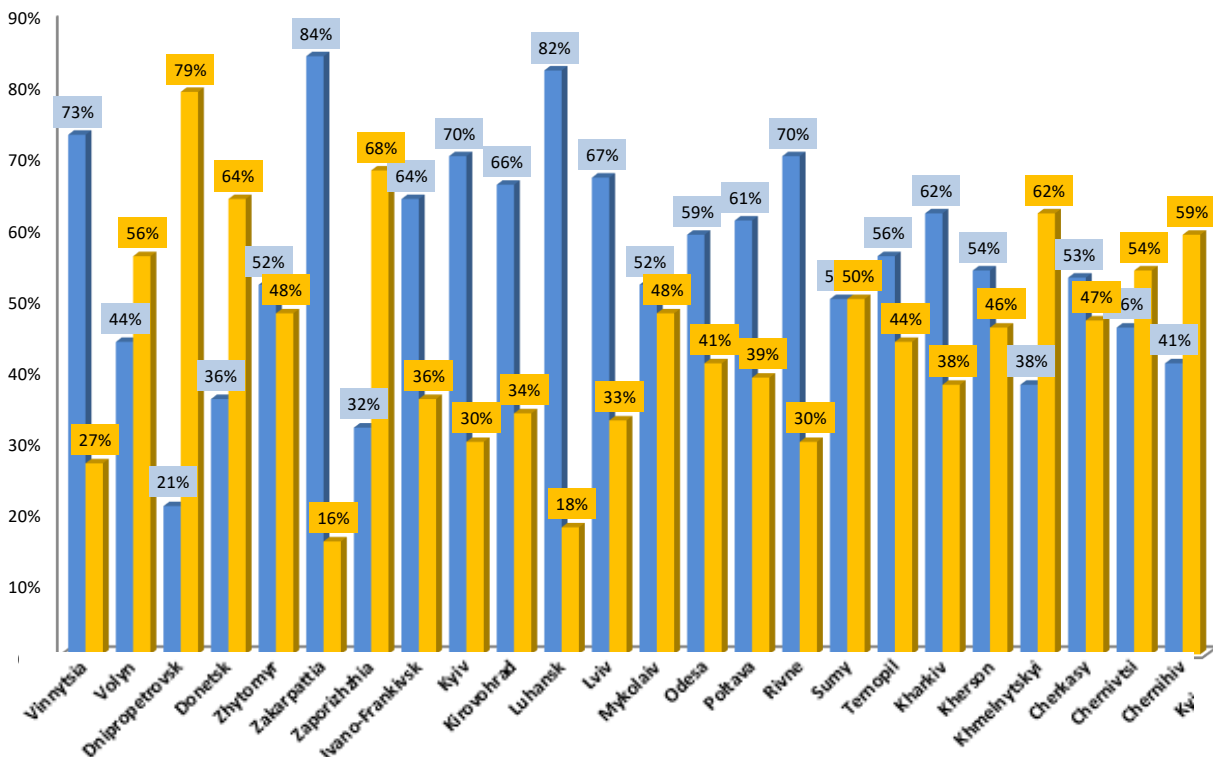

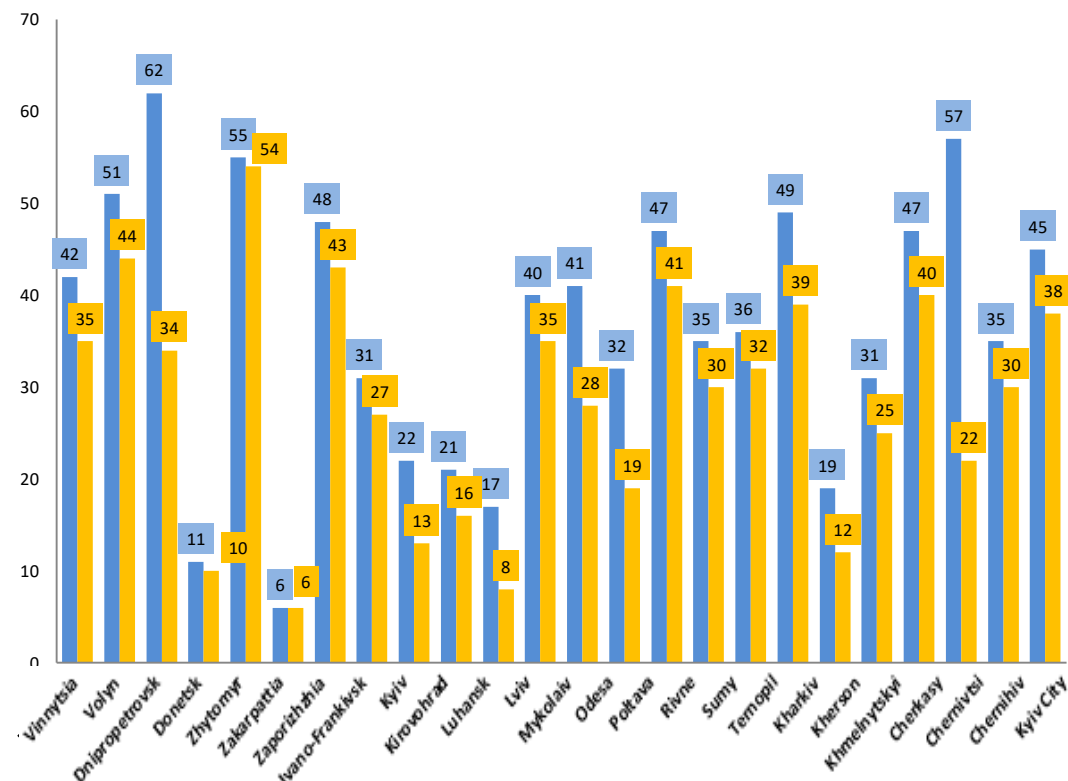

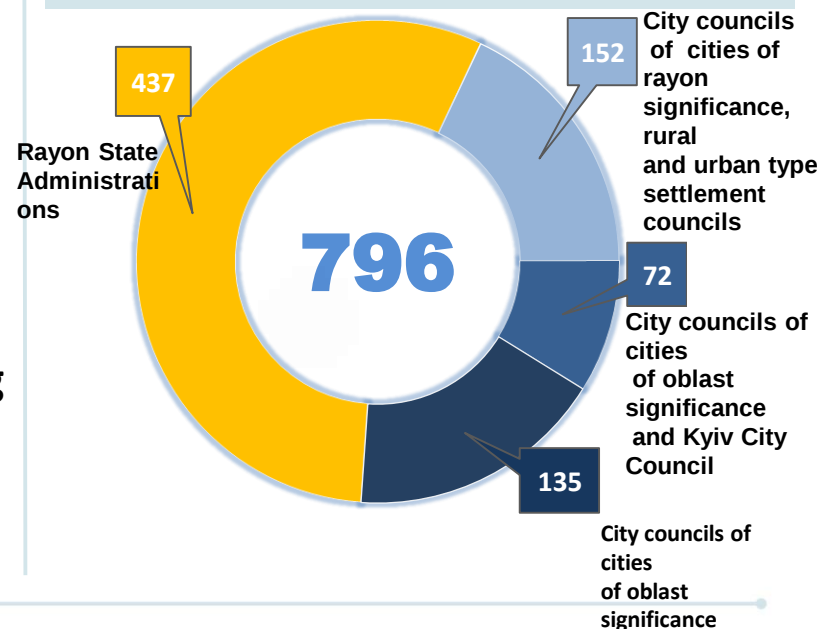
